

MUNICIPALITY OF KILLARNEY – TURTLE MOUNTAIN

BY-LAW NO. 4-2019

Being a By-Law of The Municipality of Killarney – Turtle Mountain to prescribe fees, fines, and charges for Municipal Services.

WHEREAS in accordance with Section 232 (2)(d) of The Municipal Act, a municipality may in a by-law establish fees or other charges for services, activities or things provided or done by the municipality;

AND WHEREAS The Municipality of Killarney – Turtle Mountain deems it advisable to include in one by-law the fees and charges payable to the municipality for certain services rendered by officers and employees of the municipality;

AND WHEREAS the Municipality of Killarney – Turtle Mountain deems it necessary and expedient to keep current the schedule of fees for services provided;

NOW THEREFORE, the Council of the Municipality of Killarney – Turtle Mountain, duly assembled, enacts as follows:

1. THAT the fees and charges payable to the Municipality of Killarney – Turtle Mountain for services rendered by officers and employees of the Municipality shall be set out in the following schedules attached hereto and replace any other fees charged in any municipal By-Laws related to the following:

2. THAT Council may review this bylaw annually.
3. THAT Council may from time to time amend each schedule attached to this bylaw as necessary.
4. THAT the fees, fines and charges set out in the schedules attached to this bylaw shall take precedence over any other previous related by-law.
5. THAT any unpaid fees for charges owed to the Municipality by any taxpayer, including any penalties related thereto, may be added to taxes of the said taxpayer and may be collected or enforced in the same manner as a tax as defined by The Municipal Act.
6. THAT By-law 10-2012, of the Municipality of Killarney – Turtle Mountain is hereby repealed.

c. Scanning	\$2.00 / page
3. Council Chamber Rental	
a. Rental of council chamber to local non-profit Or charitable organization	\$0.00 / day
b. Rental of council chamber to anyone other than above.	\$100.00 / day
4. Lottery Licenses – under \$3000 as per Lottery & Gaming	Free of charge
5. Trailer Court Mobile Homes License Fees	\$ 75.00 /quarter / trailer
a. Effective January 1, 2020	\$ 100.00 / quarter / trailer
6. Business License	\$200.00 / year ***

* Tax certificates will provide for one parcel of land described under each separate entry in the tax collector's roll. Tax certificates shall be processed within 3-5 business days.

** All tax information requests shall be made in writing or by email and shall be processed as time allows.

*** While working on behalf of the Municipality of Killarney – Turtle Mountain, businesses shall be exempt from this licensing requirement
