Building Permits

If you plan on building in the Municipality of Killarney – Turtle Mountain you are required to obtain a building permit prior to construction.

Development Permits

If you are planning to install a fence, build a deck or do some home improvements to your home in the Municipality of Killarney-Turtle Mountain you are required to obtain a development permit prior to the new installations. *(Some examples of home improvements include enlarging doors/windows, additions & deck replacements).*

By-Law Penalties:

- Where a permit has not been obtained prior to the commencement of the actual work, the permit fee shall be "double" the normal rates.
- Any person that contravenes, disobeys, or refuses, or neglects to obey may be guilty of an offense and subject to summary conviction under provisions of the By-Law.

Call Killarney-Turtle Mountain Planning at 523-6550 for info and an appointment. You will need a site plan and a copy of your blueprints for a building permit. Permits are required for:

- a) Construction of any building
- b) The addition, extension, improvement, alteration, structural changes, or conversion of any building, structure, or portion thereof;
- c) The relocation or removal or demolition of any building or structure;
- d) The excavation of any land for purpose of erecting or locating on or above it, any building or structure;
- e) Other examples include homes, garages, storage sheds, attached carports, decks, concrete work, apartment blocks, hotels & motels, commercial or industrial buildings, agricultural buildings, barns, sheds, etc.
- f) Development permits are required for fences and soft sided / temporary structures
- g) Permits are not required for painting or decorating. Permits are not required for other non-structural alterations or repairs where the value of such work is less than seven thousand dollars (\$7000.00).

Municipal Wells:

No chemical or chemical containers are allowed within or near the municipal wells. Anyone in contravention of this by-law could be charged a maximum of \$1000.00 or imprisonment for a period not exceeding 30 days. Please do not drive away with the hose still in the tank, as it makes for costly repairs. Also, there is no dumping of garbage allowed at any of the wells.

Sump Pumps:

In accordance with By-Law No. 5-2005, pumping water from sump pumps into the Municipal sewer line is not permitted. Water from sump pump pits and seepage should be discharged outside of the home. Putting excess water into the town sewer system not only overloads our system, it also causes pumps to run more than needed thereby causing taxpayers more money, as well as decreasing the life of the pumps so replacement is more frequent. Replacement pumps can cost anywhere from \$8000.00 to \$25,000.00.

Because of this, the Municipality of Killarney – Turtle Mountain would ask that homeowners using sump pumps not discharge the water into the sewer drain. Please discharge water outside your dwelling. Persons disregarding this request can be fined under the by-law. We thank you in advance for your cooperation. Recycling for Rural Residents:

Recycling bins are located at the North side of the Recycling Depot for rural residents. Please break down cardboard boxes. No sorting required. Please do not bring household garbage to the Recycling Depot.
