

**MUNICIPALITY OF KILLARNEY – TURTLE MOUNTAIN
BY-LAW NO. 7-2008**

Being a By-Law of the Municipality of Killarney – Turtle Mountain to amend the Town of Killarney By-Law No. 3-2005 for the completion of the Killarney – Turtle Mountain Multi-Purpose Facility

WHEREAS, the Town of Killarney, by its By-Law No. 3-2005, which was authorized by Municipal Board Order No. E-05-090, is inter alia, authorized to issue borrowing in the amount of \$2,000,000.00;

AND WHEREAS, no borrowing as authorized by said By-Law No. 3-2005 has been issued or sold;

AND WHEREAS it is deemed necessary and expedient to amend said By-Law No. 3-2005 to provide for an increase in project costs, and that the authorized amount of borrowing to be issued be increased by the amount of \$116,502.93 from \$2,000,000.00 to \$2,116,502.93.


AND WHEREAS, the Municipality of Killarney – Turtle Mountain has made arrangements to borrow from Royal Bank of Canada Life Insurance Company in the amount of \$2,116,502.93, being the costs of works completed under the authority of By-Law No. 3-2005 such borrowing to be dated July 31, 2008, to bear interest at the rate of 5.675 per annum, payable monthly during their currency, and to mature on June 30th in each of the years 2008 to 2028;


AND WHEREAS, it is deemed expedient to amend said By-Law No. 3-2005 to provide for the issuance of the aforesaid borrowing;

NOW THEREFORE, the Council of the Municipality of Killarney – Turtle Mountain, in council duly assembled, hereby enacts as follows:

1. **THAT** By-law No. 3-2005 of the Town of Killarney **BE AND THE SAME IS HEREBY AMENDED** to provide for an increase in the amount of authorized borrowing authority in the amount of \$116,502.93 from \$2,000,000.00 to \$2,116,502.93;
2. **THAT** By-Law No. 3-2005 of the Town of Killarney **BE AND THE SAME IS HEREBY AMENDED** to provide that borrowing in the amount of \$2,116,502.93 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 31st day of July, 2008, to bear interest at the rate of 5.675 per annum, payable monthly during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 30th day of June in each of the years 2008 to 2028, both inclusive;
3. **THAT** the issue of said borrowing provides financing for all costs of works completed under authority of By-Law No. 3-2005;

AND WHEREAS it is deemed necessary and expedient to amend said By-Law No. 3-2005 to provide for an increase in project costs, and that the authorized amount of borrowing to be issued be increased by the amount of \$116,502.93 from \$2,000,000.00 to \$2,116,502.93.


AND WHEREAS, it is deemed expedient to amend said By-Law No. 3-2005 to provide for the issuance of the aforesaid borrowing;
