Being a By-Law of the Municipality of Killarney – Turtle Mountain to amend the Municipality of Killarney - Turtle Mountain By-Law No. 1-2010, for the completion of the Killarney – Turtle Mountain Water Treatment Plant and pipeline

WHEREAS, the Municipality of Killarney - Turtle Mountain, by its By-Law No.1-2010 which was authorized by Municipal Board Order No. E-10-195, is inter alia, authorized to issue borrowing in the amount of \$3,750,000.00;

AND WHEREAS borrowing in the amount of \$3,750,000.00, authorized by said By-Law No. 1-2010 has been issued and sold under the authority of By-Law No. 12-2012 which was authorized by Municipal Board Order No. E-12-133;

AND WHEREAS it is deemed necessary and expedient to repeal By-Law No. 12-2012 to reflect the actual project costs that were lower than initially calculated, thereby decreasing the borrowing to be issued by the amount of \$250,000.00 from \$3,750,000.00 to \$3,500,000.00;

AND WHEREAS, the Municipality of Killarney – Turtle Mountain has made arrangements to borrow from Royal Bank of Canada Life Insurance Company in the amount of \$3,000,000.00, being the costs of works completed under the authority of By-Law No. 1-2010; such borrowing to be dated December 31, 2011, to bear interest at the rate of 4.35 per annum, payable annually during their currency, and to mature on December 31st in each of the years 2012 to 2031;

AND WHEREAS, the Municipality of Killarney – Turtle Mountain has made arrangements to borrow from Royal Bank of Canada Life Insurance Company in the amount of \$500,000.00, being the costs of works completed under the authority of By-Law No. 1-2010; such borrowing to be dated December 31, 2013, to bear interest at the rate of 4.78 per annum, payable annually during their currency, and to mature on December 31st in each of the years 2013 to 2031;

AND WHEREAS, it is deemed expedient to amend said By-Law No. 1-2010 to provide for the issuance of the aforesaid borrowing and the repeal of By-law No. 12-2012;

NOW THEREFORE, the Council of the Municipality of Killarney – Turtle Mountain, in council duly assembled, hereby enacts as follows:

- THAT By-Law No. 1-2010 of the Municipality of Killarney Turtle Mountain BE AND THE SAME IS HEREBY AMENDED to provide that borrowing in the amount of \$3,000,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 31st day of December, 2011, to bear interest at the rate of 4.35 per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2012 to 2031, both inclusive;
- 2. THAT By-Law No. 1-2010 of the Municipality of Killarney Turtle Mountain BE AND THE SAME IS HEREBY AMENDED to provide that borrowing in the amount of \$500,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 31st day of December, 2013, to bear interest at the rate of 4.78 per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "B" hereto on the 31st day of December in each of the years 2014 to 2031, both inclusive;
- 3. **THAT** the issue of said borrowing provides financing for all costs of works completed under authority of By-Law No. 12-2012 and the balance of 250,000.00 of authorized borrowing which will not be required or used is hereby cancelled ;
- 4. **THAT** the outstanding balance of \$1,866.61, of By No. 12-1012 to be paid by general operating fund.

5. THAT By-Law No. 12-2012 is repealed.
